#### **Obligations and Responsibilities of All Parents**

- a. Educational Support – Parents are expected to partner with the school in establishing family routines and priorities that support their child(ren)'s academic, social, emotional, and spiritual development.
- b. Parish Support – All parents are expected to contribute to the success of the parish by being active, contributing members of the community.
- c. Tuition – All parents are expected to enroll in TMS and make tuition payments promptly according to the payment plan they select.
- d. Policies – Parents agree to adhere to the policies as written in the St. Robert School Handbook.
- e. Home and School Association – Parents agree to support the Association's programs and activities. Each parent also agrees to complete two volunteer assignments each year and understands that such may require participation in 'Protecting God's Children' safe environment training.
- f. School Advisory Board – Parents agree to stay well-informed of the board's initiatives.

## **Obligations and Responsibilities of Parents Who Are Parishioners**

- a. Worship and Celebrate – All parents are urged to worship and celebrate the sacraments as part of the St. Robert Parish Community, thus serving as role models for their children.
- b. Stewardship of Time and Talent – All parishioners are expected to share their Time and Talent in voluntary service to the parish. Parishioners whose children attend the school are expected to fulfill their volunteer obligations to the school and be active in the parish.
- c. Financial Stewardship – In gratitude for all God has given us, all parishioners are expected to support the work of the Church by making an annual financial stewardship pledge and fulfilling that commitment. Parishioners with children in school are expected to do the same by January 1<sup>st</sup>. \$750 per year is the suggested minimum donation. Your family is expected to give at a level that is consistent with your income and your gratitude.

**This Covenant must be signed and turned in at registration along with the \$110.00 per student registration fee.**

(A copy will be kept on file at the school and the signed original will be returned to you for your records.)
