century media resource center and to look ahead to funding a bold new technology vision.

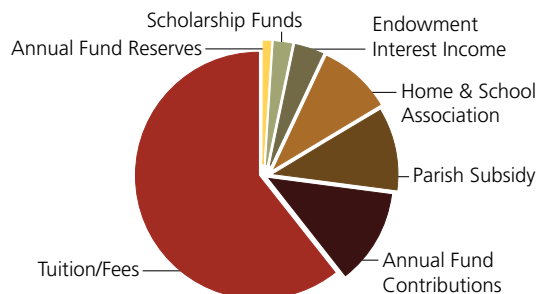

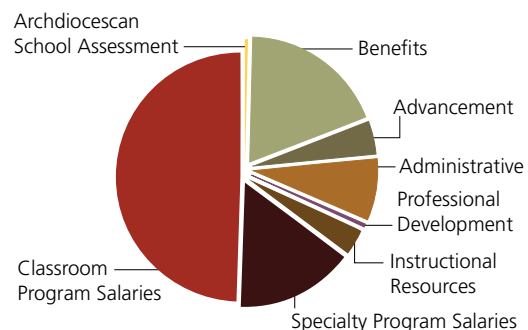

One of the key missions of the Home and School Association is to organize fund raising events that provide direct financial support for St. Robert School's short-term and long-term goals. Our primary sources of fund raising are the Emerald Auction, Rummage Sale, Kids Helping Kids Raffle, and the Magazine Drive. With your support, these events generated over \$178,000 in net income during 2009-2010. The money raised funds a subsidy to the school operating budget, many social and enrichment activities, as well as programs and equipment that enhance the education of the children in our school. Fund raising activities during the 2009-2010 school year also helped to provide program enhancements valued at over \$22,000.

Here are a few highlights:

In addition, the Home and School Association committed \$110,000 for an Apple Computer and Information Technology upgrade to occur during the 2010-2011 school year. The project includes a mobile laptop lab for student instruction, laptop computers for 20 of the teachers, replacement computers for the Media Center, SMART Boards, and a robust new wireless network.

The parents of St. Robert School volunteer at over 50 Home and School Association-sponsored programs and events each year, enabling us to collaborate with the school leadership, the faculty and the parish to build a strong community, enhance our children's educational experience, and keep our school vibrant and flourishing. Together, our efforts and contributions preserve the legacy and tradition created by those who came before us. Thank you for all of your efforts.

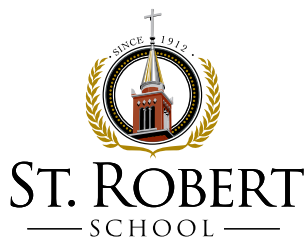

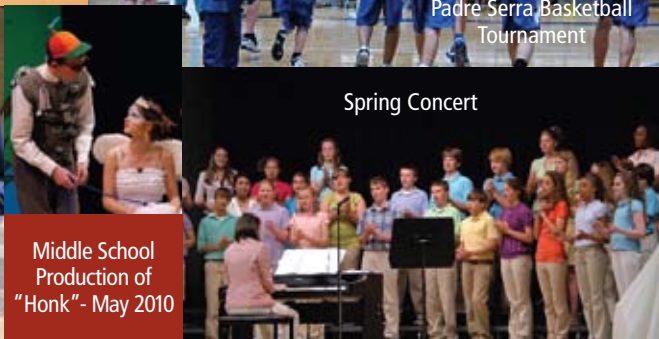
